## **2022 Community Outreach Grants**

Through the generosity of its parishioners and in keeping with our Mission Statement, St. Peter's is accepting applications for Community Outreach Grants to be awarded in February 2022. Interested organizations should submit the simplified 3-page grant application that asks information about the organization its financial position and the specifics about the program for which the grant would be used. These applications are due in the St. Peter's Church Office by Friday, December 31, 2021. All the applications will be reviewed by the Community Outreach Committee and recommendations are made to the Vestry for the awarding of the grants. It is expected that grants will be awarded in early February.

Over the past 6 years, over \$50,000 in grants has been awarded to organizations for programs locally, regionally and all the way to Ethiopia. Additionally, other funds have been earmarked to be used for local assistance programs in Nassau County.
